CND 1800+900 Monthly Match Invitations: 2017

- Dates:** Saturday, April 22, May 20, June 24, July 22, August 19, September 23, 2017, 10:00 A.M.
Pre-registration for Saturday is recommended as we will only be running a maximum of 16 shooters.
- Location:** The Waterloo County Revolver Association is located at 2278 Snyder's Road East, Wilmot Township, Ontario. Visit our website: <http://wcra.ca> for more driving directions.
- Event:** 900 Rimfire fired as per NRA Rule #3.4, 900 Centerfire fired as per NRA Rule #3.2. (NRA 1800)
Optional 900 .45 ACP as per NRA Rule #3.3. (NRA 2700)
- Membership:** Participant must show proof of recreational shooting insurance (CSSA/CFI/SFC, etc).
- Rules:** The match will be run in accordance with NRA Conventional Pistol Rules (April 2013).
- Range:** The match will be conducted on our 16 position outdoor 50 yard range (facing north) using NRA approved B-6 and B-8 targets/centers. Competitors are responsible for policing their brass and moving their shooting table at the completion of the 50 yard Slow Fire stages to the 25 yard firing line for the Timed and Rapid stages. Targets will be fixed (non-turning). START and STOP will be administered by audio electronics. Provisions have been made in the event of rain.
- Scoring:** Scoring will be done by the competitors on the line. Score cards will be passed to the left and competitors will score the target to their right. At the end of each scoring stage, the competitors are responsible for patching the centers and any shots on the bed sheet and backer board.
- Register:** Walk-on registration will be until 9:45. Pre-registration is suggested (16 total for the day)
- Entry Fees:** One caliber: \$10.00, Two/Three calibers: \$30.00

Match 1 Slow Fire Match	Targets	Shots	Time
Slow Fire NRA B-6	2	10 each target	10 Minutes ea.

Match 2 National Match Course	Targets	Shots	Time
Slow Fire NRA B-6	1	10	10 Minutes
Timed Fire NRA B-8	1	2 strings 5 shots	20 Seconds ea.
Rapid Fire NRA B-8	1	2 strings 5 shots	10 Seconds ea.

Match 3 Timed Fire Match	Targets	Shots	Time
NRA B-8	2	4 strings 5 shots	20 Seconds ea.

Match 4 Rapid Fire Match	Targets	Shots	Time
NRA B-8	2	4 strings 5 shots	10 Seconds ea.

The above course of fire is fired first with .22 rimfire handguns (NRA Rule 3.4) and then the course is repeated with a centrefire handguns (NRA Rule 3.2). Minimum requirements are 90 rounds of .22 and 90 rounds of centrefire ammunition. There will be a short break between then 22 and centrefire portion.
