



Waterloo County Revolver Association 2019 Outdoor PPC Match

- Dates:** **Saturday – MAY 25, 2019. Range open at 09:00**
Pre-shoot will be the Thursday prior to the match, 23 MAY 2019, for those who cannot attend on SAT. ONE RELAY ONLY AT 10:30
- Location:** The Waterloo County Revolver Association is located at #2278 Synder's Road East (formerly Regional Road 8). Kitchener, Ontario. The range facilities are located 45 minutes west of Mississauga Road / Hwy 401. Exit Hwy 401 using the Hwy 8 Kitchener/Waterloo exit. Take Hwy 8 and merge onto Hwy 7 West/Stratford. Exit Hwy 7 on Trussler Road, North exit. Turn left on Synder's Road. East.
- Events:** Individual 1500 PPC - firearm as per NRA Rule #3.2 or #3.3 (carry optics permitted)
Individual 600 Duty Match - firearm as per NRA Rule #3.6 or #3.7 (carry optics permitted)
- Eligibility:** Open to all Law Enforcement AND qualified (holster trained) Civilian shooters.
- Membership:** Participant must show proof of recreational shooting insurance (CSSA/CFI/SFC/CPA, etc)
- Rules:** NRA PPC Rules (2017) shall govern unless otherwise stipulated.
- Range:** Matches will be conducted on our 16 Position – Outdoor 25 yard range (facing north) B-27 and B-34 targets. Distances will be 7, 15 and 25 yards.
- Scoring:** Competitors will be responsible for picking up new targets and mounting them on command. Competitors will exchange and score targets. Competitors may not score their own targets. Competitors may only use scoring overlays.
- Register:** Walk-on registration will be from 9:30am - 1pm.
Pre-registration is REQUIRED for Pre-shoot date.
- Entry Fees:** 1500 PPC Match \$20.00
600 Duty Match \$15.00 (refires \$5.00)
- Relays:** 10am – 3pm, On the hour relays with course of fire to be determined.
- Awards:** Awards will be in cash for the 1500 and 600 will be awarded by the Lewis System. Best score per firearm will be used.
- Food:** There are establishments within 5-10 minutes drive from the range. Bottled water and pop are available in the club house for purchase.

COURSES OF FIRE

1500 Open Match (150 rounds)

Match 1 (B-27, 24 rounds)

Stage 1 – 7 Yards, 12 rounds standing unsupported in 20 seconds.
Stage 2 – 15 Yards, 12 rounds standing unsupported in 20 seconds.

Match 2 – (B27, 18 rounds)

Stage 1 – 25 Yards, 6 rounds kneeling, 6 rounds left hand barricade,
6 rounds right hand barricade in 90 seconds.

Match 3 – (B34, 24 rounds)

Stage 1 – 25 Yards, 6 rounds sitting, 6 rounds prone,
6 rounds left hand barricade, 6 rounds right hand barricade
in 165 seconds (single or double action).

Match 4 – (B27, 24 rounds)

Stage 1 – 25 Yards, 12 rounds standing unsupported in 35 seconds.
Stage 2 – 25 Yards, 12 rounds standing unsupported in 35 seconds.

Match 5A – (B27, 30 rounds)

Stage 1 – 7 Yards, Standing unsupported, 12 rounds in 20 seconds.
Stage 2 – 25 Yards, 6 rounds kneeling, 6 rounds left hand barricade,
6 rounds right hand barricade in 90 seconds.

Match 5B – (B34, 30 rounds)

Stage 1 – 25 Yards, 6 rounds sitting, 6 rounds prone,
6 rounds left hand barricade, 6 rounds right hand barricade
in 165 seconds (single or double action).
Stage 2 – 25 Yards, 6 rounds standing unsupported in 12 seconds.

600 Duty Match (60 rounds) Refires allowed, but only your best score will be recorded.

Match 1 (B-27, 30 rounds)

Stage 1 – 7 Yards, 12 rounds standing unsupported in 20 seconds

Stage 2 – 15 Yards, 6 rounds kneeling left handed, 6 rounds kneeling right handed,
6 rounds standing unsupported in 90 seconds.

Match 2 (B-27, 30 rounds)

Stage 1 – 25 Yards, 6 rounds sitting, 6 rounds prone, 6 rounds left hand barricade
6 rounds right hand barricade in 165 seconds.

Stage 2 – 25 Yards, 6 rounds standing unsupported in 12 seconds.

Unless stated, revolvers are to be shot double action only. Pistols unless SAO
must be fired double action first shot.
